There are two editions of NVivo 12 (Windows) client software: Pro and Plus. Each edition features a different level of functionality to support a range of projects and research needs.

The client license key determines the edition—some licenses allow access to more than one edition. Users with access to multiple editions can switch between them in Application Options.
